1 July 2016 at 15:00 h via eMS.





1st CfP – financing rules


Any grant requested under this CfP must fall between:

Minimum percentage (%):	20% of the total eligible expenditures of the Project
Maximum percentage (%):	85% of the total eligible expenditures of the Project

- Project partners must ensure co-financing of the Project (minimum 15%).
- Lead Beneficiary (from Croatia or Serbia) is entitled to receive an advance payment, on behalf of the partnership, in an amount of maximum 10% from the total cost of the Project.



Project duration





Partnership

- All organizations, participating under this CfP, are called partners.
- Lead Partner (LP) must be appointed among the project partners prior to the submission of the project proposal.
- Partnership consists of at least two (2) partners from both participating countries.
- The maximum number of partners in project proposal is five (5) including the Lead Partner.

Eligibility of applicants (Lead Partner and Project Partners)

- 1. be **non-profit-making legal person/entity** established by public or private law for the purposes of public interest or specific purpose of meeting needs of general interest;
- 2. be **registered** in respecting participating country (Croatia and/or Serbia);
- 3. must have **at least two partners**, one from each participating country;
- **4. Lead Applicant has to be registered at least 12 months** prior to the deadline for submission of applications.



Eligibility of activities

- All activities funded under specific objective of relevant Priority axis must demonstrate a clear crossborder effect to the Programme area.
- The Programme may finance activities, performed outside the Programme area up to the limit of 20% of the support from the EU at Programme level, ensuring that they are for the benefit of the Programme area.



Eligibility of expenditures

5 categories of expenditures are eligible :

- 1. Staff costs,
- 2. Office and administrative expenditure,
- 3. Travel and accommodation costs,
- 4. External expertise and services costs,
- 5. Equipment expenditure.

+ 2 categories:

- 6. Infrastructure and works expenditure,
- 7. Preparatory and closure costs.

Maximum ceiling of the sum of <u>the expenditure category **1**. Staff</u> <u>costs</u> should not exceed **30** % of the total eligible cost at the Project level.

Application through eMS

- The project proposal must be submitted by the Lead Partner solely through the eMS.
- The submitted Application must contain all the required data and the required accompanying documents (attached scanned documents).
- Official language of the Programme is English, therefore Application is in English.
- Applications after the deadline (1/7/2016 at 15:00 h) will not be possible within eMS.

Assessment and selection of projects

- Joint Steering Committee (JSC) acting under responsibility of Joint Monitoring Committee (JMC) is responsible for the assessment and selection process.
- The assessment process will be conducted in two steps:
 - 1. Administrative compliance and eligibility check;
 - 2. Quality assessment.



Assessment and selection of projects

- Only applications that satisfy all the administrative and eligibility criteria will be subject to quality assessment.
- The quality assessment grid is structured according to the assessment criteria:

Selection for funding

- In order to be considered for funding, an Application must fulfil all the administrative and eligibility criteria and receive at least 70 points at the quality assessment.
- After the quality assessment, four (4) ranking lists will be established, one per each Priority Axis.
- The Joint Monitoring Committee (JMC) reserves the right to:
 - re-allocate the remaining funds between priority axes (for example, if the allocation indicated for a specific priority axis cannot be used due to insufficient quality or number of applications received);
 - allocate additional Programme funds in case of large number of qualitative applications received;
 - not to use all the available funds allocated under this CfP.



Selection for funding

Under the 1st CfP an institution/partners' organization may be:

- selected for funding in not more than 2 (two)
 Applications as a Lead Partner (within different priority axes);
- Applicant applying as a Lead Partner (LP) may be Project Partner (PP) in any other Application at the same time;
- Project Partner may take part and be selected for funding in more than one Application (Operation) under this CfP.
