






Programme and Calls for Proposals In numbers

- Total Allocation: EUR 40 million; Union support (85%): EUR 34 million
- 4 Priority Axes → 5 Specific Objectives (without TA)
- 3 Calls for Proposals:
 - ¹st Call launched in 2016, 2nd Call in 2018 and 3rd (Restricted) Call in 2022
- 262 Applications Submitted
- 48 Projects Contracted (+ Technical Assistance)
- EUR 219 million requested
- EUR 37 million contracted (+ Technical Assistance)
- 126 beneficiaries in cross-border partnerships

 (34% of total Programme allocation)

Main results

- More than 88.000 ha of habitats supported to achieve a better conservation status
- 5 jointly developed/operated monitoring systems
- 4,97 MW of additional capacities for renewable energy installed

- 24 tourism supporting facilities developed or improved
- More than 1.000 persons educated in quality assurance and destination management
- More than **8.700** visitors attracted to supported sites of cultural and natural heritage

After the assessment and selection procedure, in November 2022 the JMC approved 6 projects for funding. The full applications were entered in eMS, and after their optimization, the selected projects were contracted.

These projects started their implementation as of 1 February 2023 and will be finished in 9 months (by 31 October 2023). In March 2023, the JS/MA staff provided on-site support to these beneficiaries to ensure timely execution of all planned activities, project outputs and to maximise the absorption of funds.


Therefore, the Programme is not in risk of decommittment.






Programme Tasks and Audits

Main Programme tasks performed since September 2022

- Two (online) Technical meetings (NAs/MA) held on 28 October and 9 December 2022
- Transmissions of financial data sent to the EC via SFC2014 (31 October 2022 and 31 January 2023)
- Accounts and Annual summary of controls for the 8th accounting year submitted to the EC by 15 February 2023
- All final project progress reports from the 2nd CfP approved and paid – except for project MOS-Cross2, which is still in implementation until August 2023
- **3rd (Restricted) Call** successfully launched and closed
- 6 capitalization projects contracted
- JS/MA performed monitoring visits to all 3rd CfP beneficiaries

Programme Audits

Audit of operations

The 1st phase of the Audit of operations for the 9th accounting year (2022/2023), for costs claimed in the period from 1 July until 31 December 2022, is performed by the Audit Authority until June 2023 for projects: COMMON, Heart Net, CBC Clusters and Serbian NA TA.

System Audit

All previous system audit findings were closed through the Follow-up in December 2022. No upcoming system audits.

Audit of Accounts

Audit of accounts has been successfully completed (with no findings) in February 2023 before the submission of accounts for the 8th accounting year.

All audit findings from previous audits are CLOSED.
















Interreg - IPA CBC 💭 🧾 Outreach
